# **RECRUITMENT COMPETITION: 2015**

Given the large number of employees within Transnet, Prasa, Bombela and Bombardier that are not members of UNTU, raises grave concern.

At Transnet there are 10 800 (18%) non-unionized employees, whilst at Prasa the percentage is basically the same – sadly these employees pay "Agency Shop Fee" that amounts to R90.00 whilst not enjoying protection and benefits.

At Bombela and Bombardier we have 51% work force of  $\pm 500$  employees at each of the said businesses.

In an endeavour to encourage current members to vigorously recruit the non-members as mentioned above it has been decided to introduce the following competition:-

- 1) Recruitment will be Operating Divisions (OD) specific or business although recruiters do not necessary have to be employed in the specific (OD).
- 2) Competition will only apply to Trade Union Representatives (TUR's) and members.
- 3) Full time Union Representatives (FTUR's) and UNTU staff are excluded from participating.
- 4) Recruitment fee of R100.00 per recruiter will apply.
- 5) Competition runs from 6 August 2015 to 4 September 2015 by close of business.
- 6) No late applications will be entertained.
- 7) Value / Prize Monies
  - 7.1 R5000 for most recruited R3000 for 2<sup>nd</sup> most recruited R2000 for 3<sup>rd</sup> most recruited
